Chairperson's Report

BCAC has continued to provide a strong voice across many issues for all New Zealanders diagnosed with breast cancer. In our meeting with the Minister of Health we again emphasised the need to provide greatly improved access to medicines for everyone diagnosed. We were supported by 2,800 people in our online campaign to let the Minister know of the desperate need for better treatments for those with advanced breast cancer. The lack of funding for vital medicines was brought starkly home to us through the loss of our beloved committee member Moana Papa. Mo ran out of treatment options for her advanced hormone receptor positive (HR+) breast cancer. Nothing new has been funded for this very common form of breast cancer since 2006. Ibrance is a recently registered breakthrough treatment that could make a real difference to women with HR+ breast cancer and we are working to explain the benefits of funding to PHARMAC and the Minister. But this is just one of several much needed breast cancer medicines along with hundreds of other medicines that New Zealanders miss out on because of PHARMAC's paltry, capped budget. This must be changed if the government is serious about improving the survival rate of breast cancer patients and the health of all Kiwis. BCAC met with other patient groups that share this concern, and joined with them in a new grouping called Patient Voice Aotearoa. We're hoping this collaboration will increase awareness of the need to increase government investment in medicines to give us all healthier, longer lives.


We also petitioned the Minister to extend the breast screening age band up to 74 years as this has been shown to save lives. The Ministry is "assessing the evidence" on this, but we are hopeful that they will move to extend the screening age promptly.

BCAC also believes that if our screening programme measured and reported breast density that women with a higher risk of developing the disease would be made aware of their need for high vigilance. We are seeking a conversation with BreastScreen Aotearoa and the Ministry to formulate a New Zealand response to this emerging evidence.

BCAC is disappointed that the Ministry has not implemented intra-operative radiotherapy (IORT), a technique allowing those with early, low-risk breast cancer to receive all their radiation treatment in a single dose during surgery to remove their breast cancer tumour. The National Health Committee (NHC) reviewed IORT and outlined many benefits to patients as well as efficiency and economic gains for the health system, but implementation of health innovations appears to have ground to a halt since the independent NHC was replaced by a Ministry committee established to evaluate innovations.

The passing of our beloved Moana Papa and of Cheryle Moreton-Robins, co-founder of Shocking Pink, represent huge losses to the breast cancer community. Both were inspirational, passionate and articulate in supporting others and in seeking better outcomes for New Zealanders with breast cancer. They both participated in BCAC's videos made to raise awareness of advanced breast cancer and the need for better medicines. Many other wonderful, accomplished and loved New Zealand women and men have also lost their lives to this disease, bringing grief to so many families. This ongoing tragedy is the reason we are fighting to establish the earliest possible detection, world-class timely treatments and best practice care for those diagnosed with breast cancer.

Our many member groups have continued to play their vital roles including offering support, providing information and advocacy and funding research. Please keep up the great work you're doing and stand with us in our efforts to minimise the impacts of breast cancer on our women, our families and our communities.

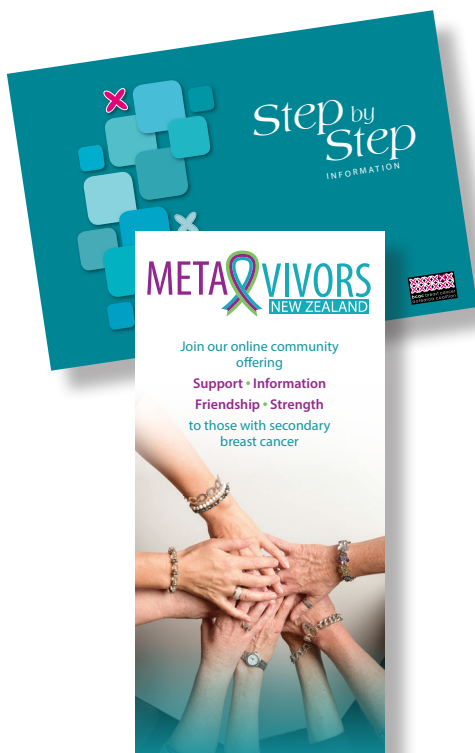
Key Achievements in 2017

Information and resources

- Delivered more than 1200 Step by Step support packs to New Zealanders newly diagnosed with breast cancer
- Provided information on breast cancer diagnosis, treatment and recovery via our website **www.breastcancer.org.nz**
- Delivered up-to-date breast cancer news, research results and events via our website, Facebook page and Twitter account
- Delivered a regular e-newsletter to hundreds of registered members and others
- Supported more than 2000 New Zealanders through the BCAC Facebook page
- Supported more than 200 New Zealanders with advanced breast cancer through the online community Metavivors NZ
- Distributed more than 1000 brochures to promote Metavivors NZ
- Responded to more than 50 queries through the BCAC website and Facebook page.

Providing a voice for those diagnosed with breast cancer

- In October 2016 BCAC launched a campaign highlighting the need for better access to medicines in New Zealand. More than 2800 submissions were delivered to the Minister of Health.
- BCAC produced an online video featuring New Zealanders with advanced breast cancer discussing their need for better access to medicines and this reached more than 50,000 via Facebook.
- BCAC committee member Melissa Bell joined Breast Cancer Trials (formerly the Australian New Zealand Clinical Trials Group) as a consumer representative.
- Fay Sowerby, BCAC secretary, is a member of the Breast Cancer Trials Fundraising and Communications Committee.
- BCAC Chair Libby Burgess is an Affiliate Member of Breast Cancer Trials.



- BCAC Deputy Chair Emma Crowley and committee member Ros Day are members of the Consumer Advisory Panel of Clinical Trials New Zealand.
- A number of BCAC committee members attended the Wellington symposium “Building a Sustainable Future – The role of the patient voice”.
- BCAC supported many women as they negotiated the health system to secure timely and appropriate treatment and care.
- Presented to the New Zealanders for Health Research Clinical Trials workshop on patient participation and recruitment.
- Met with Health Literacy NZ to provide feedback on resources for the national breast screening programme provided by BreastScreen Aotearoa.
- BCAC is a participating member of the new consumer group, Patient Voice Aotearoa - He Reo Tūroro o Aotearoa.
- Provided an invited speaker and panel member to the Breast Cancer Cure Breast Cancer Summit October 2017.
- Met with the executive of the NZ Society for Oncology to develop closer collaboration between cancer consumer representatives and researchers.

Improving access to world class treatment and care

- Represented New Zealanders with breast cancer at key international conferences including the combined Clinical Oncology Society of Australia and Breast Cancer Trials Annual Scientific Meeting.
- Met with the Minister of Health Hon. Jonathan Coleman and briefed him on a number of key breast cancer issues in New Zealand including: medicines access, the need to introduce intra-operative radiotherapy into the public health system, extending the age cohort for publicly funded breast screening to 74 years, highlighting that high breast density is a significant but currently unmanaged risk factor for breast cancer, providing timely breast reconstruction and prophylactic mastectomies, highlighted worse outcomes for Māori from breast cancer, access to clinical trials, FISH testing delays and the need for improved fertility treatment following breast cancer diagnosis.
- Delivered the Ministerial Briefing to Labour’s health spokesperson Annette King and to Peter Dunne, Associate Health Minister.

- Followed up with Peter Dunne to progress implementation of use of frozen ovarian tissue as a fertility treatment for young women diagnosed with breast cancer.
- Met Ministry of Health officials to follow up on issues raised in our Ministerial briefing.
- Made a detailed submission to PHARMAC in response to their consultation regarding changes to their procedures as a result of TPP requirements.
- Met with PHARMAC representatives to discuss the urgent need for better access to new and innovative medicines.
- Met with pharmaceutical companies to encourage them to apply for registration and funding for key breast cancer drugs and to offer their products at affordable prices.
- Made a submission to PHARMAC supporting their decision to fund Perjeta for HER2+ metastatic breast cancer patients.
- Made a further joint submission with the Breast Cancer Foundation New Zealand to PHARMAC to re-consider the criteria for the funding of Perjeta and strongly urged PHARMAC to extend funding for this medicine to all patients currently being treated with trastuzumab for metastatic breast cancer.



Improving outcomes for Māori and Pasifika women

- Liaised with Māori and Pasifika women affected by breast cancer and related advisory groups.
- Highlighted the poorer outcomes of Māori women with breast cancer.
- Appealed to BreastScreen Aotearoa, the Ministry of Health's Cancer Team and the Minister of Health to achieve real and significant improvements in the engagement of Māori women as well as the speed of detection and treatment for those with breast cancer.

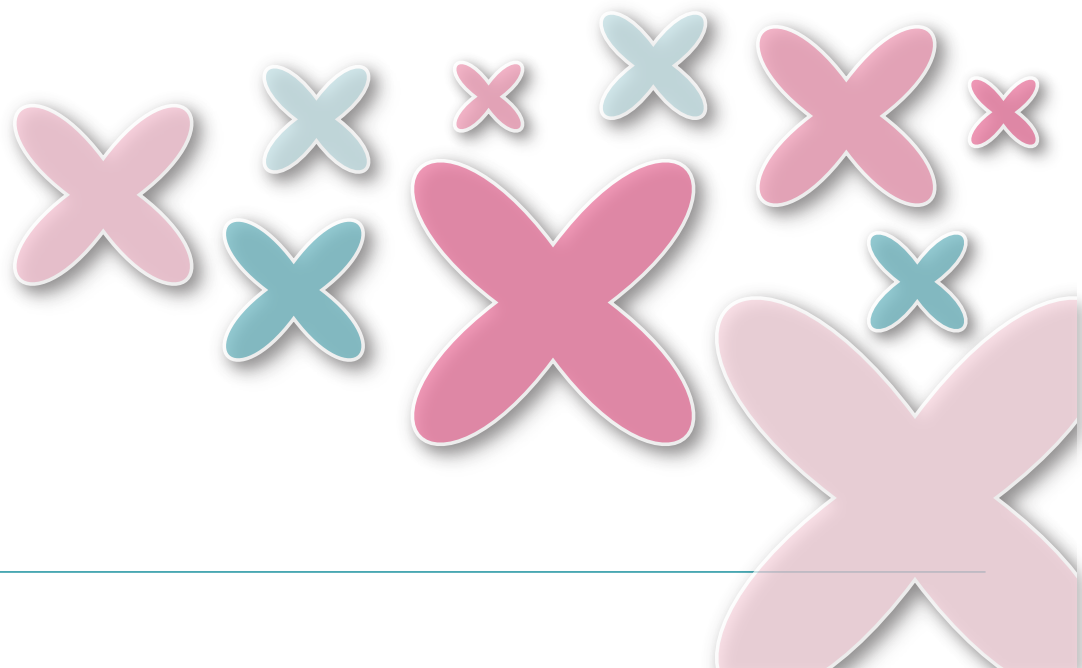

In Memory – Moana Papa

The Committee noted with deep sadness the passing of committee member Moana Papa in February 2017. Moana joined BCAC in 2008 and was our guide, mentor and active leader in our ongoing efforts to improve health outcomes for Māori and Pasifika women with breast cancer. She represented us on the Māori Leadership Group of the Northern Cancer Network, working to influence the Northern District Health Boards, and she served on PHARMAC's Consumer Advisory Committee. Moana formed Wahine Toa, an informal South Auckland group to consult Maori and Pasifika women on breast cancer issues. She was an important participant in our annual briefings for the Minister of Health, an active contributor to the Metavivors' Facebook group, and was always ready to offer herself as the face and voice of breast cancer when media attention was needed. Moana will never be forgotten for her tenacity, love and leadership in trying to make things better for those affected by breast cancer in Aotearoa and their whanau.

We were also thrilled to receive many donations from those in the community and thank all those who have contributed and supported us during the year.

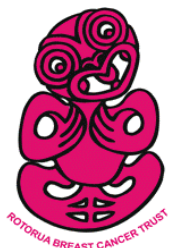
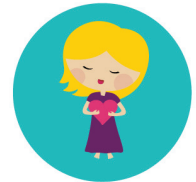




BCAC Member Groups

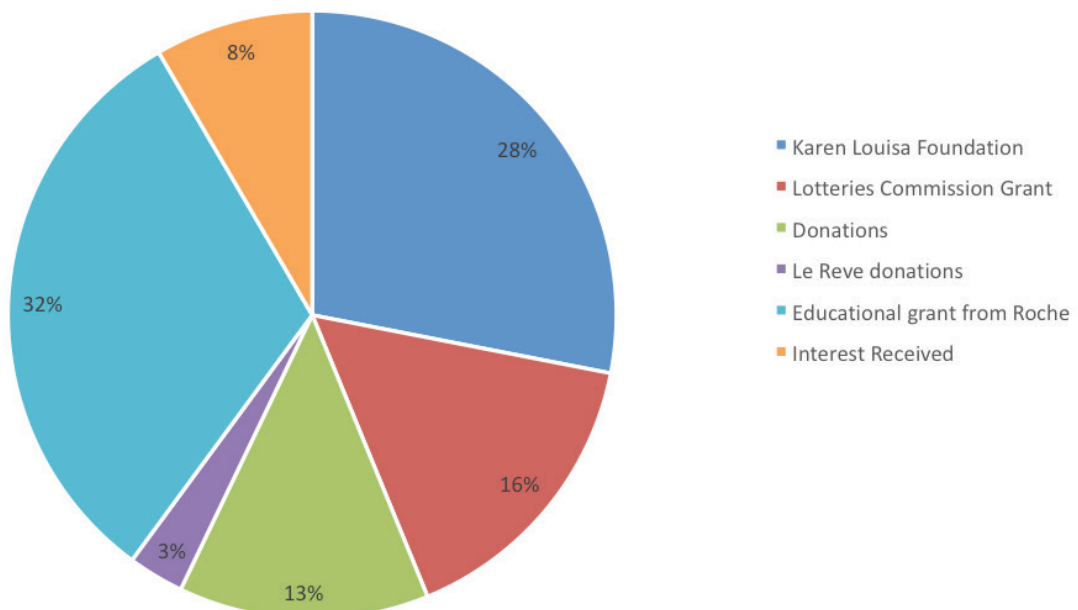

BCAC Revenue to 31 March 2017



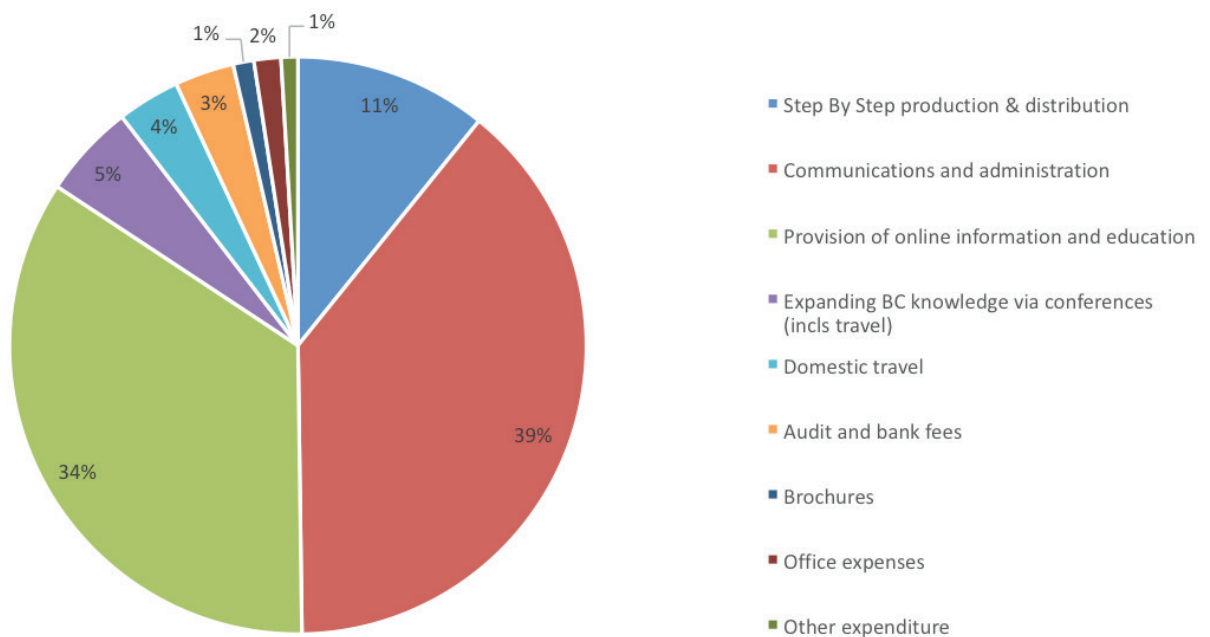

To provide information and support to empower those with breast cancer to make informed choices about their treatment and care

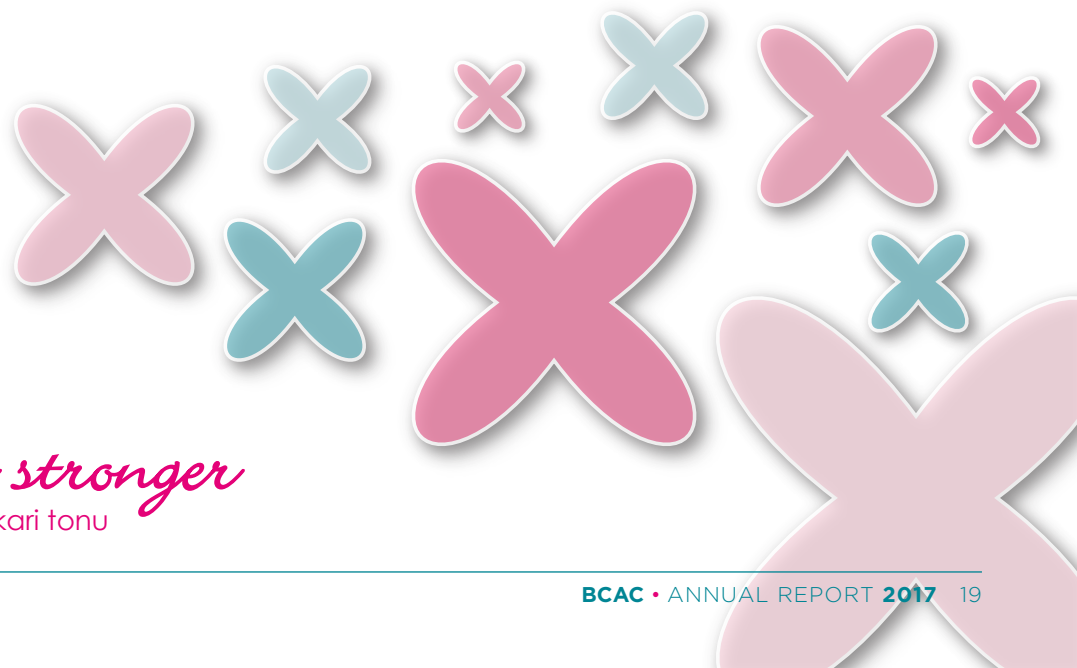
- Continue to distribute our Step by Step support packs
